

PARK RULES

- Any violation of park rules is cause for removal. Any act or conduct by any person and or pet which interferes with, impedes or disrupts, impairs the safety of others is prohibited.
- Customers are responsible for keeping picnic area(s) free of trash at all times and placing collected trash in the proper trash receptacles.
- Sponsors are responsible for the cleanliness of reserved area. Area will be inspect prior to departure.
- Sponsors are required to accompany guest throughout the duration of their stay.
- Smoking is **NOT** allowed in any facility.
- Quiet hours from 10 p.m. to 7 a.m.
- Sponsors are responsible for the safety and behavior of their family/guest at all times.
- Minors must be supervised at all times. All persons under 18 years of age must have a parent present.
- Sponsors are responsible for the upkeep and care of all assigned facilities and agree to pay the replacement or repair costs for any damage to government property.
- Pets must be on a leash at ALL times. **Pets are NOT allowed in cabins, shelters, swimming area, or restrooms.** Customers are responsible for the pick up/ disposal of all pet waste.
- Fires are permitted in grills and fire rings **ONLY. NO** bonfires. Fires must be attended to at ALL times and thoroughly extinguished prior to departure.
- Sponsors are responsible for ensuring that all family/guests consuming alcoholic beverages meet the minimum drinking age of 21 years old.
- Sponsors are responsible for ensuring alcoholic beverages are not served to anyone they believe to be intoxicated and/or not in control of themselves (DRAM Shop theory).
- Possession of firearms, ammunition, loaded firing devices, bows and arrows, crossbows or other weapons is prohibited.
- The cutting, gathering of trees or parts of trees and or the removal of trees from the park is prohibited.
- Vehicles shall not be parked in violation of posted restrictions or parked in such a manner as to obstruct or impede normal or emergency traffic movement. Vehicles shall be operated in accordance with posted restrictions and regulations, applicable Federal, state and local laws. ATV's, unlicensed motorcycles and motorized skateboards are prohibited.
- Fishing is permitted except in the swimming area, marina walkways, marina boat storage area and on or around boat ramps.
- Boat ramp and courtesy dock located next to ramp are for launching and recovering boats and trailered watercraft only. Boats parking/siting must use the courtesy dock located opposite the boat ramp.
- Absolutely **NO WAKE** inside break water/buoy markers within cove area. Boats must maintain idle speed within this area.
- Swimming is not permitted around or near marina, fishing pier and courtesy docks. Swimming is at your own risk.

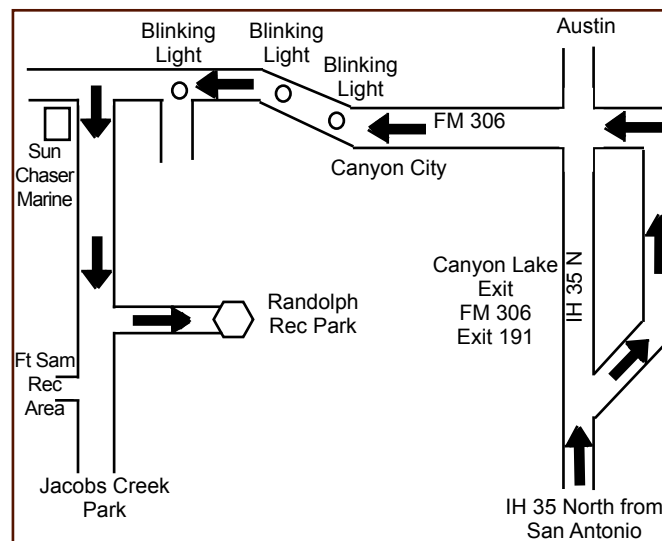

BOAT RENTAL POLICY

- No pets on rental boats
- Boat fees do not include gas
- All boats due back 1 hour before closing
- Boats identified with * above require a boater's safety course. Course offered 7 days a week from 9 a.m. to 3 p.m. at the office
- Fishing is only authorized on a designated boat for fishing, i.e., Fish & Ski, Bass and 16' Fishing boats
- Renter must have a valid DoD ID Card (Active Duty, Active Reserves, Dependents (age 18 and up), DoD Civilian)
- Unreserved boats will be rented on a first-come, first-serve basis
- Limited boats may be reserved 30 days in advanced and require a \$25 deposit. Deposit is non-refundable if cancelled less than 24 hour advanced notice. Boat must be rented for a minimum 4 hours
- Reservation will be held for 15 minutes after designated start time. Reserved boats not rented will be forfeited or first-come, first-serve and will forfeit \$25 deposit
- Driver must not consume alcohol during rental

RESERVATION POLICY

Pavilion/Group Camping Area/Picnic Area:

- All fees will be charged between the 1st and 5th of the reservation month. Reservations are confirmed only after payment.
- Cancellations/Changes must be made two weeks (14 days) prior to reservation date in order to receive a refund, minus a \$5 administrative fee. Cancellations made between 14 and 2 days prior will forfeit 50% of the total charge. Changes made between 14 days and 2 days will be charged an additional \$20. All cancellations/changes made within 2 days of reservation date will NOT receive a refund.
- Day use areas are available from 8 a.m. to 10 p.m.. All patrons must depart no later than 10 p.m.

Campsites:

- Camp sites are available on a first-come, first served basis.
- Tents are not allowed on the granite pads located around the shelters.

Cabins/Shelters/RV Sites:

- Cabins, shelters and RV sites may be reserved by active duty six months in advance; all others may reserve units up to three months in advance.
- All fees will be charged between the 1st and 5th of the reservation month. Reservations are confirmed only after payment.
- Cancellations/Changes must be made two weeks (14 days) prior to reservation date in order to receive a refund, minus a \$5 administrative fee. Cancellations made between 14 and 2 days prior will forfeit 50% of the total charge. Changes made between 14 days and 2 days will be charged an additional \$20. All cancellations/changes made within 2 days of reservation date will NOT receive a refund.
- Reservations are not transferable from one party to another.
